## **1997 Business Meetings Bring Changes to Caucus Bylaws**

The 125<sup>th</sup> Annual Meeting was extremely productive for the PHSC. During the two Business Meetings, the members voted on several amendments to the Bylaws as well as a dues policy.

The new dues policy, proposed by the Executive Board and ratified by the members, requires that all members joining on or after November 10, 1997, pay \$5 (US) dues. All PHSC members in good standing as of November 9, 1997, are exempted from dues for a period of one year although they are strongly encouraged to make a \$5 donation. The PHSC will also set aside funds to help defray the cost of membership for those deemed to be in need by the Finance Committee. The dues period begins and ends at midnight on the first day of the Annual Meeting, but dues paid between August 15 and the Annual Meeting will be applied to membership for the period leading up to the Annual Meeting and for the following year until the next Annual Meeting.

The Bylaws was also amended to include three new standing committees. The Outreach

The Caucus held a well-attended social at the Rock Bottom Brewery which proved to be fun and relaxing for everyone.

The Insights in Public Health Leadership Session was dynamic and enlightening. Four of the foremost leaders in public health presented tips on leadership and participated in a question and answer session with attendees. Dr. Noreen Clark, Dean of University of Michigan School of Public Health, suggested that students develop a perspective and stay close to the community. APHA Immediate Past President, Dr. Barry Levy, emphasized that all students are leaders and if you consider yourself a leader and act as a leader, you will have opportunities to be a leader. Dr. Mary Des Vignes-Kendrick stated that a leader must be optimistic and believe that he/she can make a difference and must focus on the small gains. Dr. William Roper pointed out that students should set priorities and communicate their strengths and ideas clearly and convincingly. The resounding theme of the session seemed to be that if you set your goals, gain the necessary skills, and are committed and focused, leadership is attainable.

The *Leadership Roundtable* Session provided the ideal opportunity for members to get involved with the Caucus. The brainstorming sessions yielded many creative ideas for the upcoming year. New officers were also installed at this session. Congratulations to President Maria Cervania (University of Illinois - Chicago), President-Elect Stuart Usdan (University of Alabama -Birmingham), Secretary Heather Young (George Washington University), and Treasurer Adriana Linares (University of Texas - Houston).

# Public Health Student Caucus Call for Abstracts for the 1998 Annual Meeting

The Caucus seeks abstracts in two categories: 1) Students in public health or related fields are invited to submit abstracts for papers on any topic and/or the Annual Meeting theme of "Public Health and Managed Care." Student papers must reflect work undertaken while in school. 2) We also invite abstracts for papers and panel discussion proposals on public health student issues (such as education, curricula, training, employment trends, leadership, advocacy, etc.) in general and/or as they relate to the Annual Meeting theme.

All abstracts must adhere to the new APHA guidelines and must also include: 1) two copies of

the author/co-author ID form; 2) two copies of the abstract; 3) five copies of the abstract without the authors' names to be used for blind review; 4) a self-addressed stamped envelope to be used for acceptance or rejection notification.

Student submissions must be accompanied by a letter on school stationary confirming student status.

There are a variety of opportunities for students to present their work at the Annual Meeting. In addition to the Public Health Student Caucus call for abstracts, the Committee on Affiliates, the Medical Care Section, and the Latino Caucus are sponsoring competitions specifically for student papers. All of the Sections/SPIGs/Caucuses are also eager and committed to accepting student papers for both presentation and poster sessions.
