A ttention all public health students! The 128th Annual Meeting of the American Public Health Association is rapidly approaching. The event will be held November 12-16 in Boston, MA. The

theme for the meeting is "Eliminating Health Disparities."

presentations, renowned speakers, and aisles of booths with public health information and representatives.

Oral and poster presentations will take place throughout the meeting in addition to the business meetings and welcome sessions. General principles of the Environmental Section are: to recognize and support different interests, viewpoints and backgrounds of Section Members; provide access to information about Section activities; facilitate proactive and well-planned advocacy; and seek opportunities to work closely with other APHA Sections and activities (for

example, the National Environmental Coalition, the Environmental Health Partnership, the Environment and Health Task Force; the Centers for Disease Control and Prevention, National Center for Environmental Health).

Goals of the Section are to improve environment and health practice such that public health and environmental protection are integrated into practice level decision-making; strengthen APHA's role as a respected national and international force to improve environmental health and other policies so that the policies recognize environmental

components of disease and promote prevention; mobilize Section members to collaborate with APHA staff and leaders in work on environmental health policy and practice and serve as the primary source for APHA staff and leadership of expertise and guidance

on environmental health issues; build and sustain a strong and active membership base through strategic recruitment, opportunities for participation, effective communication and member recognition; and ensure that the APHA Annual Meeting is a dynamic and current forum for environmental health issues.

The Section is led by its elected officials – chairperson, chair-elect, secretary, six Section councilors elected from the members at-large, and four members of the Section elected to the APHA Governing Council. In addition there are numerous opportunities for other Section members to become involved in the Section in a leadership capacity. Helping with the Section newsletter, chairing one of the

various standing or ad hoc committees, or participating in the APHA policy process are all activities that are open to any of our members. In addition, the Section Council has established additional committees over the past several years to focus more attention on the priority goals outlined above.

Unite to End Gun Violence

e encourage you to bring *First Monday 2000: Unite to End Gun Violence* to your campus on October 2, 2000! *First Monday 2000*, sponsored by Physicians for Social Responsibility (PSR) and the Alliance for Justice, is a national campaign promoting education and action geared toward reducing gun violence. Students from schools of public health will be organizing hundreds of campus programs, along with students at schools of medicine, nursing, law, and social work. City-wide events in over 40 locations will feature elected officials, experts on gun violence, parents, students, and celebrities. These events aim to keep the

momentum from the Million Mom March going, and catalyze activism for common sense gun laws that goes beyond October and into 2001.

Gun violence represents a nationwide public health crisis that kills more than 32,000 Americans each year, 4,000 of whom are children. Only cancer, heart disease, and motor vehicle accidents cause more deaths in this country. These statistics highlight the severe public health implications of gun violence —and force us to see that we must take action to reduce its deadly effects. APHA Executive Director, Dr. Mohammed N. Akhter, MD, MPH, speaks for the organization when he says, "Easy access to guns makes it very difficult to address other areas of violence prevention. As a first step, Congress must enact sensible gun control measures."

he APHA Annual Meeting is both the oldest and largest gathering of public health professionals in the world. More than 13,000 people will attend the 128th meeting, which will feature over 500 information booths and 900 oral and poster sessions where more than 3000 scientific papers will be presented.

Attending the Annual Meeting is a terrific way to get involved in APHA and PHSC. Many Sections, in addition to PHSC, highlight student work at the meeting via numerous scientific sessions. First Monday will be a call to action for students to get involved in gun violence prevention. For information, email Andrew Kessler, First Monday Project Coordinator, Physicians for Social Responsibility, at akessler@psr.org, or call Andrew at (202) 898-0150 ext. 240. Detailed information about First Monday and the schools that are currently participating can be found at www.firstmonday2000.com, or www.psr.org/firstmonday.html.

All participating schools will receive (at minimal cost) a copy of "America, Up in Arms," a 30-minute documentary film produced by the Alliance for Justice. Directed by award-winning filmmakers Liz Garbus and Rory Kennedy, it presents three faces of the gun violence epidemic, each a dramatic illustration of the public health crisis caused by the ready availability of guns in the U.S.:

- A California teenager shot unintentionally by a friend who was playing with a gun he thought was unloaded;
- A despondent 19-year-old in Texas who committed suicide with a handgun; and
- A 26-year-old shot and killed by armed robbers on the streets of Philadelphia.

The film can be used as the centerpiece of your school program. It explains the public health implication of gun violence and

how government regulation of gun design, manufacture, advertising, and distribution could save thousands of lives each year.

If you are thinking of organizing a *First Monday* event, Andrew will send you detailed information about how to handle the logistics, find space, get publicity, etc. You'll get an organizer's kit with publicity posters and a short preview of the film. A complete resource package will be sent with talking points for discussion after the film, ideas for guest speakers, and action items for students. You might want to plan a town meeting with police, community leaders, and victims of gun violence. Or convene a panel to discuss the epidemiological research on gun violence. Or hold a local rally or gun buyback program. Certainly you will want to develop questions for candidates running for office this November, to find out where they stand on gun issues. And "get out the vote" drives are critical.

I sincerely hope you will all join with *First Monday* 2000. Let us know what you are planning. The film will be shown at the APHA Annual Conference in Boston this November. A *First Monday* 2000 panel presentation, to be sponsored by the PHSC, will also include students who organized particularly interesting and effective programs for October 2. We'd like to hear from you.
